INTRODUCTION

The proponent made online application vide proposal no. **SIA/WB/INFRA2/402657/2022** dated **10 October 2022** seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. **8(a) Building / Construction** projects under Category "**B2**" of EIA Notification 2006.

SEAC recommended the proposed project for Environmental Clearance during its 60th meeting held on 28.12.2022.

The PP appeared for a hearing before SEIAA on 08.06.2023 and gave a presentation to SEIAA. SEIAA decided to refer the matter to the Forest Department for clarification regarding the provision of the West Bengal Trees (Protection and Conservation in Non-Forest Areas) Act, 2006 and the West Bengal Trees (Protection and Conservation in Non-Forest Areas) Rules, 2007 pertaining to this particular case. SEIAA also requested the PP to seek and submit a legal opinion as per the provisions of the above-mentioned Acts and Rules.

The PP uploaded their reply on 08.07.2023. SEIAA considered the submission uploaded by the project proponent in its 9th meeting held on 20.07.2023 and the case was deferred for further consideration till receipt of valued opinion from Forest Dept.

Clarification from the Department of Forests vide letter No. 1275-For/FR/O/G/6C-24/2016 dated 03.08.2023 has been received on 03.08.2023. The copy of the letter is attached as annexure 1.

DELIBERATION IN SEIAA

SEIAA considered the clarification received from the Department of Forests vide letter No. 1275-For/FR/O/G/6C-24/2016 dated 03.08.2023 wherein it is mentioned "Since the DFO, South 24 – Parganas has already approved the Plantation Plan of the Project Proponent, and considering that the Project relates to the social / health infrastructure sector, SEIAA may take a suitable decision in the matter." Now SEIAA is in consideration of the clarification received from the Forest Department endorsing the Plantation Plan approved by the DFO in the instant case and decided to accept this particular health project proposal. This should not be taken as precedence for any other project in future.

Considering the recommendation of SEAC, submissions from the project proponent and clarification received from the Forest Department, SEIAA recommended the project proposal for EC.

RECOMMENDATIONS OF SEIAA

The application for EC is approved based on the Building Permit No. 2022090043 dated 15.07.2022 issued by the KMC.

Based on the submission made by the PP, the committee after careful consideration and detailed deliberation observed that the project proponent has obtained non-cluster certificate mentioning that the sand block does not form a cluster with any adjacent sand block. But, the SEAC observed that the proposed project is in cluster with another sand block of M/s. West Bengal Mineral Development and Trading Corporation Limited - Block ID - MIN_DJ_1 (Proposal No. SIA/WB/MIN/422496/2023). All the documents are in the name of M/s. Excellent India Build Construction, whereas the applicant is Smt. Renu Yadav. Therefore, the SEAC recommended that the present EC application cannot be processed further and the PP should apply afresh for ToR.

SEAC recommended for rejection of the proposed project during its 7th meeting held on 12.07.2023. Based on the submission and presentation made by the PP, the committee observed that the entire plot area for the proposed project as per the geo-coordinates mentioned in the approved Mining cum Progressive Mine Closure Plan falls within the potential mining zone recorded in the approved District Survey Report (DSR) of Jhargram district. The sand block does not fall within any cluster. However, the SEAC observed that:

- a) The approved Mining Plan with Progressive Mine Closure Plan has been manually erased and corrected without authentication.
- b) The plot area also observed to be in cluster with an adjacent project of M/s. Chakraborty Enterprise SIA/WB/MIN/426857/2023, which was considered in the 2nd SEAC meeting held on 07.06.2023.
- c) The PP has however, submitted a cluster certificate mentioning that the proposed project is not clustering with any other sand block.
- d) Valid LoI has not been submitted.

Therefore, the SEAC recommended that the present proposal may be rejected. The PP is requested to apply afresh under Terms of Reference.

Reference: Your letter No. 1106/EN/T-II-I/077/2012 (Part-II) dated 12/06/2023

Sir,

In inviting a reference to the subject mentioned above, I am directed to convey the comments of the Department of Forests as follows:

To harmonise the developmental aspirations of society with the need to protect and conserve trees in non-forest areas, the Department of Forests has taken a decision to review in entirety the existing West Bengal Trees (Protection and Conservation in Non-Forest Areas) Act, 2006 and West Bengal Trees (Protection and Conservation in Non-Forest Areas) Rules, 2007.

Based on the experience of the implementation of the above-mentioned Acts and Rules, one issue is Compensatory Afforestation by a Project Proponent on a land different/ separate from the land from which the Project Proponent proposes to undertake the development project. This concept is in vogue across the country in terms of the Forest Conservation Act, 1980 (where forest land is utilized for non-forest purposes).

Since the DFO, South 24-Parganas has already approved the Plantation Plan of the Project Proponent, and considering that the Project relates to the social / health infrastructure sector, SEIAA may take a suitable decision in the matter.
