Ltd. has obtained EC vide EC Identification No. EC23B038WB178886, File No. EN/T-II-1/006/2023, Date of Issue of EC - 07/07/2023 for the proposed Residential Complex "DTC Capital City" at Rajarhat, Dag No.- 875, 4291, 4293, 4294, 4295, 4327, 4295/5210, 4292/5211, P.O-Kamduni, Mouza-Matiagaccha, P.O.- Barasat -2, J.L. No.-187,188, P.S.- Rajarhat, Under Kirtipur-2 Gram Panchayat, Dist- 24 Parganas(N), West Bengal.

SEIAA considered the complaint and decided to forward the same to both Land & Land Reforms & Refugee Relief & Rehabilitation Dept. and Panchayat & Rural Development for examining the veracity of the complaint as Land & Land Reforms & Refugee Relief & Rehabilitation Dept. is repository of land documents and Panchayat & Rural Development has sanctioned the building plan with due consideration.

**4.** Validity of EC for mining projects.

After detailed discussion, SEIAA decided that the validity of EC for any mining project would be 5 years as per the scheme of mining mentioned in the approved mining plan. However, the PP may apply for extension of EC with revised scheme of mining plan before expiry of 5 years.
