Sir.

I am directed to refer to your letter no 2348/EN/T-II-1/048/2022 dated 04.10.2023 received in the Ministry for seeking clarification regarding exemption of Environment Clearance for proposed Medical Institution and Hospital Building of All India Institute of Medical Sciences (AIIMS) Kalyani, West Bengal.

- 2. In this regard, Ministry vide Notification S.O. 3252(E) dated 22.12.2014 amended schedule 8(a) of the EIA notification, 2006, "Industrial shed, school, college, hostel for educational institution shall be exempted from requirement of Environmental Clearance (EC) but shall ensure sustainable environmental management, etc." Further, Ministry vide OM No 19-2/2013 IA-III dated 09.06.2015 has already clarified that in case of Medical Universitions, the component of Hospitals will continue to require prior Environmental Clearance.
- 3. It would be relevant to mention that the above referred Notification dated 22.12.2014 and OM dated 09.06.2015 are available in public domain at https://environmentclearance.nic.in/writereaddata/EIA_Notifications 18_S03252E_22122014.pdf and https://environmentclearance.nic.in/writereaddata/OMs-2004-2021/175_OM_09_06_2015.pdf, which are self-explanatory in nature. Accordingly, SEIAA, West Bengal is requested to take further necessary action in light of the provisions mentioned in the aforesaid Notification and OM of the Ministry.
