# I. CONSIDERATION/RECONSIDERATION OF ENVIRONMENTAL CLEARANCE

(1) Proposed residential complex at Premises No. – 184, J.N. Mukherjee Road, R.S. Dag No. – 160, 161, 82/267, 74/254, 82, 83, 84, 85, 86, L.R. Dag No. – 168, 169, 171, 172, 88, 89, 90, 91, 92, Khatian No. – 251, J.L. SEAC recommended the project for Environmental Clearance.

# DELIBERATION IN SEIAA

SEIAA considered the recommendation of SEAC and observed the following:-

a) Clearance from Airport Authority of India to be uploaded.

b) Permission from SWID as mentioned in the letter vide No. 34/E-Adv/2021-2022 dated

16.12.2021 of HMC to be obtained and uploaded.

c) Continuous extraction of ground water for a long period results in depletion of the ground aquifer. This is a serious environmental hazard inviting subsidence and contamination of arsenic etc. For the said project application for EC, SEIAA prefers not to allow extraction of ground water during operational phase of the project. The HMC need to ensure supply of piped water supply mentioning a feasible time frame in this regard. In case the piped water supply is not made available within a period of 5 (five) years, the EC would liable to be cancelled. The project proponent (PP) is requested to take up the matter to HMC and address the issues.

## INTRODUCTION

The proponent made online application vide proposal no. SIA/WB/MIS/183102/2020 dated 28.11.2020 seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. 8(a) Building and Construction projects under Category "B2" of EIA Notification 2006.

The project was placed in the 30th meeting of SEIAA held on 13.08.2021 and it was noted that a complaint has been made against the project for starting construction activities and filling up of water bodies without obtaining EC. SEIAA referred back the proposal to SEAC for conducting a field inspection.

This is an existing project (16132.45 sqm.) which was below the purview of EC. The present application is made for construction beyond 20000 sqm. in the 'fresh EC' category.

The project site is inspected by the SEAC on 06.10.2021. The proposal is forwarded to SEIAA by SEAC on 22.03.2022.

#### DELIBERATION IN SEIAA

SEIAA considered the recommendation of SEAC and observed the following:-

a) Mohiary No. 2 Gram Panchayat mentioned vide their letter no. nil dated 12.09.2019 that they would not be able to provide water supply to the project and necessary permission to be obtained for extraction of ground water.

The proposed project is a large scale high density project with a built up area of 39558.65 sqm. and a total footfall of 9532 (Fixed - 1594, Floating - 7922, Service - 16) persons. The provision for water supply as well as other services needs to be addressed by the local body while approving the building sanction plan.

Continuous extraction of ground water for a long period results in depletion of the ground aquifer. This is a serious environmental hazard inviting subsidence and contamination of arsenic etc. For the said project application for EC, SEIAA prefers not to allow extraction of ground water during operational phase of the project. The local body need to ensure supply of piped water supply mentioning a feasible time frame in this regard. In case the piped water supply is not made available within a period of 5 (five) years, the EC would liable to be cancelled. The PP is requested to take up the matter to local body or any other competent authority and address the issues.

Therefore, the application for EC is deferred for additional information.

No valid document from the BLLRO office has been produced by the PP in this regard. The project proponent was requested to submit the supporting documents from BLLRO as stated above. The project proponent uploaded documents on 16.03.2022.
