SEIAA considered the recommendation of SEAC in 45th meeting held on 01.02.2022 and referred the proposal back to SEAC for reappraisal under violation category in view of MoEF&CC O.M. No. 22- 21/2020-IA.III[E 138949| dated 28.01.2022.

SEAC recommended the project for Environmental Clearance under violation category.

SEIAA considered the recommendation of SEAC and observed that the project proponent (PP) should submit the following in the PARIVESH Portal:-

1. Title Deed and porcha of the additional land proposed for undertaking exclusive tree plantation to be uploaded. 2. Details of need based activities for local people specifying the location of proposed

activities to be undertaken and tentative target beneficiaries to be covered.

3. The PP is also requested to deposit one time processing fee as per Notification No 924/T-II-1/021/2022 dated 23.05.2022 issued by Dept. of Environment, GoWB and upload the paid challan in the PARIVESH Portal.  Proposed Residential Complex "Rosedale Garden Housing Complex" at Plot No. AA-III/BLK-3, Action Area - III, New Town, Kolkata - 700156, West Bengal by M/s Rosedale Developers Pvt. Ltd. (SIA/WB/MIS/50005/2018)

The project proponent (PP) M/s. Rosedale Developers Pvt. Ltd. were informed to appear before SEIAA in the 62nd meeting of SEIAA held on 02.06.2022 for non-compliance of payment of the requisite amount towards Remediation Plan and NCRAP since 10.08.2020. It was found that the PP did not appear for the hearing and instead a representative of the appointed RP appeared in the matter. In order to ascertain the present status of the PP, the matter was referred to Senior Law Officer, Dept of Environment for her opinion and advice.

In view of the opinion obtained from the Senior Law Officer, Env. Dept., the PP is to be informed that the Resolution Professional (RP) who has been appointed by NCLT as per provisions of law to manage the assets of the company during the insolvency process, is not an authorised representative of the PP in general. The demand for payment of requisite amount for Remediation Plan and NCRAP cannot be claimed from RP. Hence, the PP is requested to make the requisite payment forthwith in order to avoid rejection of the EC application. In case of non-payment of the requisite amount by the PP within a period of 30 days, subsequent penal actions would be taken.
