III MISCELLANEOUS

(1) Discussion on draft DSRs of Uttar Dinajpur, Dakshin Dinajpur, Alipurduar and Murshidabad.

SEIAA is yet to receive the official copies of four rectified DSRs from the Dept. of Industry, Commerce & Enterprises on 22.06.2022. Considering the urgency of sand mining projects and the approval of DSRs from the competent authority, the office is requested to place the rectified copies of the DSRs in the next meeting of the SEIAA as and when the same is received officially from the Dept. of IC&E at the earliest.

(2) Dealing with large scale projects in peri-urban areas.

It is observed that a number of high-rise, high-density projects are coming up in different areas falling under rural, peri-urban as well as municipal areas where there is no provision of water supply, sewerage, solid waste management and other basic infrastructure. The local authorities such as GPs are according sanction or submitting declarations that such infrastructure will be created.

Sanctioned plan document is a pre requisite for processing of EC applications. PP approaches SEIAA after receiving all necessary approvals from the concerned departments. It is assumed that for implementation of any large scale project commitment towards provision of all basic infrastructures will be taken up by the respective sanctioning authorities before completion of the project.

SEIAA is issuing the EC based on those undertakings which are issued by local authorities. Unfortunately, it is observed that even after completion of the project, when the project is operational for a substantial period, such commitments are not met. Non compliance of such commitments eventually affects the environmental parameters.

Basic infrastructure should precede the approvals / sanctions of the projects by the respective departments / local authorities. The MS, SEIAA may write to concerned departments to address the issues.
