SEIAA attended the meeting and pointed out issues including those related to CCR and stone crushing units. Written communication to MoEF&CC on the matter to be done shortly.

B. CONSIDERATION/RECONSIDERATION OF ENVIRONMENTAL CLEARANCE

(1) Proposed construction of B+G+10 storied Building for State of the Art, Director General, GSI Office, at Plot No. GN-40, Sector – V, Salt Lake, Kolkata, West Bengal by **M/s. Central Public Works Department**

INTRODUCTION

The proponent made online application vide proposal no. **SIA/WB/INFRA2/409765/2022** dated **08 December 2022** seeking environment clearance under the provisions of the EIA Notification, 2006 for the above-mentioned project. The proposed project activity is listed at SL. No. **8(a) Building / Construction** projects under Category "**B2**" of EIA Notification 2006.

SEAC, during its 69th meeting held on 11.03.2023, recommended the proposed project for Environmental Clearance with the additional condition that in addition to Kendriya Vidyalayas, other local schools, especially of the underprivileged communities, may also be considered under needbased EMP. Help may also be rendered to the local civic bodies for the increasing the environmental awareness, or improvement and maintenance of the locality.

The proposal was placed before SEIAA in its 96th meeting held on 25.04.2023 and it was observed that some documents required to be uploaded in the PARIVESH Portal. The project proponent uploaded documents on 01.06.2023. SEIAA considered the submission made by the project proponent vide letter No. 54(3)/EE & SM (C-II)/Rajarhat (Kolkata)/2022/28 dated 01.06.2023 uploaded on 01.06.2023. An inspection of the project has been conducted by the WBPCB on 15.05.2023. As per the inspection report it appears that the project proponent has already initiated construction activity without obtaining EC which is gross violation of the EIA Notification, 2006 and its subsequent amendments.

The project proponent was required to appear for a hearing before the SEIAA, WB before a final

decision on EC application is taken. Subsequently, the PP has been informed to appear for hearing before SEIAA on 03.07.2023.

DELIBERATION IN SEIAA

SEIAA considered the deliberations made by the project proponent in the hearing and the recommendations of SEAC. The PP tried to explain that they have done only construction of retention wall to prevent land subsidence (after demolition work of the existing building at the site was completed). They also mentioned that the retention wall also done to prevent cracks in adjoining building.

It was observed that as per inspection report that works for substantial portion of the basement of B+G+10 storied building had been completed.

As per the SOP, there is no provision for any construction work of the main structure is allowed to be undertaken prior to EC.

Therefore, the present application for EC is rejected.

The PP is directed to stop all construction work for the project till EC is granted and apply for ToR under the violation category.

RECOMMENDATIONS OF SEIAA

The EC application is rejected.

Based on the inspection report of WBPCB, the committee noted that the PP has already started construction work at the project site, which is a gross violation of EIA Notification, 2006 and its subsequent amendments. Therefore, the SEAC recommended that the present proposal of the PP shall be rejected and the PP shall apply afresh under violation category.

The proposal was placed in the 5th meeting of SEIAA (Reconstituted on 17.05.2023) held on 26.06.2023 and decided to call the PP for a hearing before a final decision on EC application is taken. Subsequently, the PP has been informed to appear for a hearing before the SEIAA, WB on 03.07.2023.
