PP is therefore, requested to submit a superimposed map of the entire project boundary within the colour coded zoning map mentioning all the coordinates.
- ii. The present application is made for HIG-1 for a built up area of 61,805.40 sq.m. on 3.63 acres of land. As per the land use compatibility certificate of SJDA, the total land area for the project is mentioned as 81.19 acres with a sanctioned total built up area of 632665.81 sqm. It is being observed that in spite of clearly mentioning about the required submittals, PP along with consultants are misinterpreting / misguiding by incomplete submission again and again. The deliberations made during the hearing of the PP on 02.03.2023 has been uploaded in the PARIVESH portal in the minutes of 89th SEIAA meeting held on 02.03.2023. Subsequent individual application by the PP for individual project within the same master plan, are creating a substantial delay in processing of EC applications which is causing enormous wastage of time and energy for all. SEIAA considers this as misrepresentation and wilful submissions of partial information underplaying environmental concerns. In case of such repetitive and wrongful actions, SEIAA would be compelled to take action against the PP and consultants.
