# DELIBERATION IN SEIAA

The project is an existing industry having Rolling Mill of capacity - 4275 MT/ Month. A field inspection was made on 26.03.2019 where it was noticed that the present green belt is around 3% only of the total project area.

#### RECOMMENDATIONS OF SEIAA

- c) There is an existing permission for drawl of 25 KLD of ground water. Since the present requirement for the project is to the tune of 41 KLD of ground water, permission for the same

to be obtained.

- d) A detail master plan showing all roads, loading / unloading facilities, structures and other facilities.
- e) A plantation plan duly signed by concerned Divisional Forest Officer.

SEIAA considered the reply submitted by the project proponent dated 11.02.2021. Project proponent informed that Mr. Anil Kumar Loharuka of M/s Leisure Stockist Pvt. Ltd. would act as the Authorised Signatory on behalf of all 64 applicants.

The land classification for the dag no. 441 is mentioned as 'Doba'. The project proponent has submitted a declaration regarding the present land classification status of all dag nos. within the project, wherein there is a mention about the conversion certificate vide CON/1303/BLLRO/RAJ/17 dated 01.12.2017 of the said dag no. to 'Baastu' /Housing Complex. Later the project proponent has submitted a declaration that they would not be undertaking any construction activity in that parcel of land containing the water body.
