SEIAA considered the submission of the project proponent dated 05.04.2021 wherein it was mentioned that the Mining Lease and Mining Plan are valid upto 27.07.2025. But as per the submitted documents it is observed that the modified Mining Plan signed by Chief Mining Officer is valid upto 21.02.2023. The project proponent is requested to clarify the discrepancy regarding the date of validity of the Mining Plan.

It is found from the PARIVESH portal that some of the updated documents are not uploaded. The project proponent has submitted some of such documents in hard copy format however some of those are deficient due to lack of proper content or content without signature. SEIAA considered the submission made by the project proponent vide their letter no. Nil dated 22.03.2021 and observed the following:-

 The project proponent submitted the proposal based on the Building Plan No. 1430/RPS dated 21.12.2020 and sanctioned by Executive Officer, Rajarhat Panchayat Samity and NOC issued by NKDA vide Memo No. 5373/NKDA/BPS- 04(40)/2014 dated 14.10.2020. During processing it was observed that there is a waterbody present in that project area vide Dag No. 441. In the sanction plan somehow the waterbody was not shown. When noted, the project proponent was requested to submit a revised sanction plan. The project proponent though submitted a revised plan but the same is not having any sanction no. nor vetted by NKDA. Further to mention that consequent to demarcation of the waterbody which was otherwise shown as parking area, a designated area is to be demarcated for such parking area which was otherwise shown within the waterbody.
