## MINUTES OF THE 43<sup>RD</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 06<sup>TH</sup> DECEMBER, 2018 AT PRANI SAMPAD BHAVAN

The forty-third meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 06<sup>th</sup> December, 2018 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5<sup>th</sup> Floor, LB - Block, Sector – III, Salt Lake, Kol-106. Following cases were discussed:

I. Discussion on the new Website to be developed for SEIAA.

A presentation on developing a website for SEIAA was made and relevant issues were discussed to make it user friendly and effective. Further discussions will be held for finalization of the website in due course of time.

II. Discussion on essential documents to be submitted for industrial projects.

It is found from time to time that in absence of any structured format for submission of the proposals for the industrial projects, the appraisal of the project without the relevant documents becomes difficult. It was decided to prepare a detailed checklists of the documents to be submitted for the industrial projects by the project proponents. Hence, an exercise was initiated for preparation of the said checklist.

## III. Stipulated conditions.

1. Application for Environmental Clearance of proposed expansion of the construction project "The 42" at 42B, Chowringhee Road, P.S. Shakespeare Sarani, Kolkata – 700 071 by M/s. Chowringhee Residency Pvt. Ltd.

The SEIAA considered the stipulated conditions for Environmental Clearance recommended by the SEAC and it was decided that the project proponent should submit site plan in Auto CAD format showing the exclusive tree plantation area in poly line both for the existing and proposed situation.

## II. Miscellaneous

 Application for Environmental Clearance of proposed expansion of the Residential Building complex "Atmosphere" at 1001/A, Eastern Metropolitan Bye Pass, Mouza

 Purba Topsia, JL No. 7, PS – Tiljala, Kolkata – 700 046, West Bengal by M/s.
 Forum Projects Pvt. Ltd.

SEIAA noted the communication of SEAC vide Memo No. 673-2N-37/2010(E) dated 03.12.2018. It is observed that the stipulated conditions were issued on 15.02.2018 and after that an inspection to the site was carried out on 18.07.2018 where it was found that construction work for the expansion project had already been started without obtaining EC.

Thus, SEAC is requested to appraise the case based on the facts with specific recommendations.

2. Change of name of project proponent - application for environmental clearance for expansion of project at Kanjilal Avenue, Tehsil - Durgapur, Dist - Paschim Burdwan by M/s. Super Smelters Limited.

The matter was discussed and it was decided that the project proponent would apply for the ToR as well Environmental Clearance in the present name and withdraw all earlier applications.

## 3. Functioning of SEIAA Secretariat

For smooth functioning of SEIAA it is felt that an operational SEIAA Secretariat is urgently required. For the said purpose it was decided to send a detailed proposal regarding personnel, infrastructure, space for office etc. to the Environment Department, Govt. of West Bengal for obtaining necessary approval.
