MINUTES OF THE 14TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 09TH AUGUST, 2017 AT PARIBESH BHAVAN

The fourteenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 09th August, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Salt Lake, Kolkata-700106. Following cases were discussed:

I. Stipulated Conditions

1. Application for Environmental Clearance for the proposed housing complex at 34, Diamond Harbour Road, Kolkata -700 027, West Bengal by M/s. DSK Real Estates Ltd.

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will:

- 1) Conform to the clauses mentioned in the "Manual on Norms and Standards for Environment Clearance of Large Construction Projects" published by MoEF & CC, GoI.
- 2) Incorporate details of all dimensions and functional, positional arrangement of STP, compost plant and rainwater harvesting reservoir in the approved plan.
- 3) Submit final site plan (in conformity with the final approved plan) showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD 2010) & hard copy formats.
- 4) The project proponent is requested to submit the microclimatic study of the project area delineating the exclusive tree plantation area ensuring that the plantation area does not fall under shadow zone.
- 2. Application for Environmental Clearance for the proposed housing complex at Mouza Madurdaha, Ward No. 108, under Kolkata Municipal Corporation, Kolkata -700 099, West Bengal by M/s. Kolkata Heights Pvt. Ltd.

SEIAA examined the recommendation of SEAC as well as the documents submitted by the project proponent. Land documents submitted by the project proponent identify land character as "Beel" i.e. water body. Hence the authority decided to refer the proposal back to SEAC for review.

3. Application for Environmental Clearance for the proposed housing complex at Mouza – Daulatpur, Block Bishnupur, JL. No. 79, Diamond Harbour Road, P.O. Joka, P.S. – Bishnupur, under Kulerdari Gram Panchayet, Dist. South 24 Parganas, West Bengal by M/s. DTC Projects Pvt. Ltd.

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will:

1) Conform to the clauses mentioned in the "Manual on Norms and Standards for Environment Clearance of Large Construction Projects" published by MoEF & CC, GoI.

- 2) Incorporate details of all dimensions and functional, positional arrangement of STP, compost plant and rainwater harvesting reservoir in the approved plan.

Limited, West Bengal.

SEIAA considered the submission of the project proponent and approved the prayer for change of name of project proponent for Environmental Clearance vide No. 2653/EN/T-II-1/027/2012 dated 28.10.2014 from 'GSA Commercial Private Limited' to 'Metalik Fuel Private Limited'.
