

**MINUTES OF THE 09TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 13TH JUNE, 2017 AT PARIBESH BHAVAN**

The ninth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 13th June, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector - III, Salt Lake, Kolkata-700098. Following cases were discussed:

I. Cases for Final Environmental Clearance

- 1. Environmental clearance application for the proposed Residential Complex at Mouza - Khasmallick & Hariharpur, JL. No. 35 & 11, PS - Baruipur, Dist. 24 Parganas (S), West Bengal by M/s. Broad Tie Up Pvt. Ltd. & Ors.**

The Authority considered the recommendation as well as the conditions proposed by SEAC and approved the proposal for Environmental Clearance.

- 2. Environmental Clearance application for the proposed Residential Complex at JL. No. 74, Mouza - Digberia, P.S. Madhyamgram and J.L. No. 42, Mouza - Kutulsahi, P.S. - Barasat, Badu Road, Dist - North 24 Parganas, West Bengal by M/s. Swadha Nirman Pvt. Ltd.**

The Authority considered the recommendation as well as the conditions proposed by SEAC and approved the proposal for Environmental Clearance.

- 3. Environmental Clearance application for the proposed Residential Complex at Raja Rammohan Roy Road, under KMC Ward No. 121, Kolkata - 700 041 by M/s. Merlin Projects Ltd.**

The Authority considered the recommendation as well as the conditions proposed by SEAC and approved the proposal for Environmental Clearance.

- 4. Environmental Clearance for the proposed expansion - cum modification of Residential cum Commercial Complex "South Winds" at Mouza - Manikpur, PS - Sonarpur, JL No. 77, Rajpur Sonarpur Municipality Ward No. 23, Dist - 24 Parganas (South), West Bengal by M/s. Srijan Realty Limited & Others.**

The Authority considered the recommendation as well as the conditions proposed by SEAC and approved the proposal for Environmental Clearance.

II. Stipulated Conditions

- 1. Environmental Clearance application for the proposed expansion of residential complex "Merlin Water Front" at Premises No. 40, Swarnamoyee Road, Ward No. 39, under Howrah Municipal Corporation, P.S. Shibpur, Dist. - Howrah, West Bengal by M/s. Zoom Vanijya Pvt. Ltd.**

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will:

- i) Confirm to the clauses mentioned in the "Manual on Norms and Standards for Environment Clearance of Large Construction Projects" published by MoEF & CC, GoI.

- ii) Provisions of Solid Waste Management Rules, 2016 and Construction and Demolition Waste Management Rules, 2016 should be complied with.
- iii) Submit site plan showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD) & hard copy formats.

2. Environmental Clearance application for the proposed Housing Complex at Mouza – Domjur, Mouza – Makardah and Mouza – Pubannapara, P.S. Domjur, Dist. Howrah, West Bengal by M/s. Riya Manbhari Projects LLP.

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will:

- i) Confirm to the clauses mentioned in the “Manual on Norms and Standards for Environment Clearance of Large Construction Projects” published by MoEF & CC, GoI.
- ii) Provisions of Solid Waste Management Rules, 2016 and Construction and Demolition Waste Management Rules, 2016 should be complied with.
- iii) Submit site plan showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use clearly demarcating Phase I and Phase II both in soft (Auto CAD) & hard copy formats.

3. Environmental Clearance application for the proposed expansion (Phase-2) of Residential Complex “Mani Casadona” at Plot No. IIF/04, Action Area –II, New Town, PS – Rajarhat, New Town, PS – Rajarhat, New Town, Kolkata Development Authority, Dist. – 24 Parganas (North), West Bengal by M/s. Magus Bengal Estates LLP.

The SEIAA approved the stipulated conditions proposed by SEAC. It was further decided that the project proponent will:

- i) Confirm to the clauses mentioned in the “Manual on Norms and Standards for Environment Clearance of Large Construction Projects” published by MoEF & CC, GoI.
- ii) Provisions of Solid Waste Management Rules, 2016 and Construction and Demolition Waste Management Rules, 2016 should be complied with.
- iii) Submit site plan showing Land use distribution with polyline and corresponding legend mentioning Area and Percentage of each use clearly demarcating Phase I and Phase II both in soft (Auto CAD) & hard copy formats.

III. Miscellaneous

1. Amendment of Environmental Clearance for the proposed Education cum Social Complex at Plot No. III A/1, Action Area III, New Town, PS – Kolkata Leather Complex, West Bengal by M/s. Acharya Mahapragya Mahashraman Education & Research Foundation (AMMERF).

SEIAA examined the submission of the project proponent and decided that since the project comprises of both Educational as well as Non Educational components, any expansion will require prior Environmental Clearance.

2. **Amendment of Environmental Clearance for the proposed installation of induction furnace 10x20T, 0.55 MTPA rolling mill along with captive power plant 70 MW (25 MW coal based and 45 MW dolochar-coal mix based) at Mouza- Mathurakismat & Amba, Vill-Gokulpur, P.O-Shyamraipur, P.S-Kharagpur, Dist- Paschim Medinipur by M/s. Orissa Metaliks Private Ltd.**


SEIAA examined the submission of the project proponent and decided to forward the same to SEAC for appraisal.

3. **Change of Name of the Company - Environmental clearance for the proposed expansion of cement grinding unit from 1.5 MTPA to 2.5 MTPA by upgrading existing ball mill with roller press and V-separator at Village - Amdanga, P.O. MTPS (DVC), P.S. - Gangajalghati, Dist. Bankura, Pin - 722 183, West Bengal by M/s. Lafarge India Pvt. Ltd. to M/s. Nuvoco Vistas Corpn. Ltd.**


SEIAA examined the submission of the project proponent and it is observed that EC was granted to M/s. Lafarge India Pvt. Ltd. However, the document submitted by project proponent issued by Ministry of Corporate Affairs, GoI for change of name shows that the name has been changed from "Lafarge India Limited" to "Nuvoco Vistas Corporation Limited". Hence the project proponent may be requested to come up with the necessary rectification.


4. **Amendment of Environmental Clearance for the proposed grinding Unit cement (2MTPA) and CPP (10MW), at Panagarh Industrial Park (Plot no. B2 & B3), Aushgram - 11, Galsi - II and Kanksa, Burdwan. By - M/s Emami Cement Ltd.**

SEIAA considered the submission of the project proponent and recommended the proposal.
