## MINUTES OF THE 49<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 14<sup>TH</sup> MARCH, 2019 AT PRANI SAMPAD BHAVAN

The forty-ninth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 14th March, 2019 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

## I. Cases for Final Environmental Clearance

1. Application for Environmental Clearance for the proposed residential complex at L.R. Dag Nos. 898, 900; L.R. Khatian Nos. 4382-4421, 4424-4428, 4506 and 4542, Mouza-Mankundu, Holding No. 183/1, Khan Road, P.O. & P.S.-Bhadreshwar, Municipality-Bhadreswar, J.L. No.-9, Ward No.-20, Dist-Hooghly, Pincode-712136, West Bengal by M/s. PGE Infosolution Pvt. Ltd. and Others. (SIA/WB/NCP/71131/2017).

The Authority considered the recommendation of SEAC. However, it was noted that the existing built up area was mentioned as 19850.575 sq.m. During inspection the actual built up area could not be checked. The project proponent should submit either the Completion Certificate or a report by a COA registered architect mentioning the existing built up area of the project.

2. Application for Environmental Clearance for the proposed expansion of the existing cement grinding unit from 2.0 MTPA through process optimization only and capacity utilization in the existing plant equipments at Panagarh Industrial Park of WBIDC, Block – Aushgram-II, Village – Kota, District – Purba Bardhaman, West Bengal by M/s. Emami Cement Ltd.

(SIA/WB/IND/30014/2018).

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

3. Application for Environmental Clearance for the proposed residential complex at Mouza-Bade Hooghly, J.L. No.-80, R.S Dag No. 1326, 1327, 1328, 1329, 1331, 1332, 1333, 1351, 1364, 1365, 1366, 1367, 1368, 1369, 1370, 1371, 1372, 1385, 1385/1712, 1386, 1435/1718, P.S Sonarpur, under Poleghat Gram Panchayat, Dist.-South 24 Pgs, West Bengal by M/s. Everlink Builders Pvt. Ltd. & 57 Others.

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

## II. Stipulated Conditions

1. Proposed expansion cum modification of Hospital Building "Desun Hospital" at premises no. 720, Anandapur, Ward No.108, BR-XII, P.S.-Anandapur (earlier Tiljala), under Kolkata Municipal Corporation, Kolkata-700107, West Bengal by M/s. P.N. Memorial Neurocentre & Research Institute Limited. (SIA/WB/NCP/80815/2018).

The SEIAA approved the stipulated conditions for Environmental Clearance recommended by the SEAC with the additional condition that the project proponent would submit the Completion Certificate of the existing phase of the project.

2. Proposed expansion of Residential Complex "THE 42" by M/s. Chowringhee Residency Pvt. Ltd. at 42B, Chowringhee Road, under KMC Ward No. 63, PS – Shakespeare Sarani, Kolkata – 700 071, West Bengal. (SIA/WB/NCP/76550/2018)

The SEIAA examined the letter dated 06.03.2019 submitted by the project proponent along with the report by the architect and it is found that the report has mentioned about the facts of the earlier EC conditions and proposed expansion project. The Environmental Clearance was issued vide Memo No. EN/2087/T-II-1/063/2013 dated 19.08.2014 for a total built up area of 63614.62 sqm. for the building configuration - 1 Block - G+58+2 refuge floors, Existing Building G+2 storied, 1 Block of MLCP & Residents Activity Centre 2B+G+7 storied based on the Building Permit No.2012070281 dated 14.12.2012. In case of any variation in the configuration from the EC conditions vis-a-vis the approved drawings, the necessary approval from KMC should be submitted. The present status of the project regarding the total built up area, total number of floors constructed so far and the number of tenements / flats is not mentioned. The same may be submitted duly certified by a COA registered architect with date.
