MINUTES OF THE 73RD MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 14TH JANUARY, 2020 AT PRANI SAMPAD BHAVAN

The seventy third meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 14th January, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Violation

1. Application for Environmental Clearance for the proposed construction of Office cum Guest House building by M/s Dong Fang Electric (India) Pvt. Ltd. at plot no. AH-5, Premises no. MAR-16-1111, Action Area IA, New Town, Kolkata-700156, West Bengal. (SIA/WB/MIS/44974/2018)

SEIAA considered the recommendation of SEAC along with the Remediation Plan and NCRAP submitted by the project proponent vide letter no. DE(1)PL/SEAC/EC/412 dated 20.09.2019.

SEIAA approved the proposal for Environmental Clearance.

II. Environmental Clearance

1. Application for Environmental Clearance for the proposed setting up of DI Pipe manufactureing unit of capacity 97,200 MT/annum by M/s Kejriwal Castings Limited at Khatian no. 5770, J.L. no. 58, Vill-Gopalpur, Bamunara Industrial Area, Mouza-Bamunara, PS-Kanksa, Durgapur, PIN-713212, Dist.-Paschim Bardhaman, West Bengal. (SIA/WB/IND/41755/2018)

SEIAA considered the recommendation of SEAC along with the O.M.s of MoEF&CC vide F. No. 22-23/2018-IA.III (Pt) dated 31.10.2019 and F. No. 22-23/2018-IA.III dated 30.12.2019 respectively.

SEIAA approved the proposal for Environmental Clearance.

2. Application for Environmental Clearance for the Proposed expansion project from 90,000 TPA billet (2 X 12T Induction Furnace) and 1,62,000 TPA wire rods to 1,92,000 TPA wire rods and 60,000 TPA HB wires by adding 1 X 15T induction furnace by M/s Supershakti Metaliks Ltd. at Plot no.s 3333(Part), 3367(Part), 3369(Part), 3370(Part), 3371(Part), 3372(Part), 3373, 3374 (Part), 3375, 3376(Part), 3377(Part) & 3513(Part), J.L. No. 85, Mouza – Gopinathpur, Kanjilal Avenue, Tehsil-Durgapur, Dist.-Paschim Bardhaman, West Bengal. (SIA/WB/IND/35205/2018)

SEIAA considered the recommendation of SEAC along with the O.M.s of MoEF&CC vide F. No. 22-23/2018-IA.III (Pt) dated 31.10.2019 and F. No. 22-23/2018-IA.III dated 30.12.2019 respectively and observed that the project has the provision for developing 22% green area within the project site. As per the DMC's letter no. DMC/PW/1709 dated 23.07.2007, the land parcel in between the project boundary and the road was allowed for possible plantation. Since the letter was issued in 2007, the project proponent is required to get the permission along with the site plan specifying the plantation area from Durgapur Municipal Corporation afresh.

3. Application for Environment Clearance for the proposed expansion of existing Steel Plant by installation of Induction Furnaces (4X15T) and with 1,00,000 TPA capacity Rolling Mill by **M/s Calstar Sponge Limited** at J.L. No. 58, Khatian No. 2461, Mouza-Bamunara, (Dag No. 4533, 4544 to 4563, 4566, 4569 to 4572), PS-Kanksa, Dist-Pachim Bardhaman, West Bengal. (SIA/WB/IND/34029/2016).

SEIAA considered the recommendation of SEAC along with the O.M.s of MoEF&CC vide F. No. 22-23/2018-IA.III (Pt) dated 31.10.2019 and F. No. 22-23/2018-IA.III dated 30.12.2019 respectively.

SEIAA approved the proposal for Environmental Clearance.

4. Application for Environmental Clearance of proposed residential complex by M/s Happy Niketan Private Limited on Holding no. 449/A, G. T. Road – Lot-2 (449/A/1, G. T. Road), J.L. No. 15, L R Dag No. 10164, 10167, 10166, 11147, 11146, 11131, 11138, 11132, 11164, 11162, 11172, 11169, 13215, 13219, 13214, 13213, 11129, 11171, 13203, 11163, 11168, 13205, 13207, 13222, 13221, 13220, 13208, 13209, 13210, 13206, 11142, 11143, 11141, 13204, 11145, 13217, 13218, 13212, 13211, 13216, 11144, Mouza – Mahesh, Serampore, Dist.- Hooghly, West Bengal. (SIA/WB/MIS/34591/2019).

SEIAA considered the recommendation of SEAC along with the submission made by the project proponent vide their letter no. NIL dated 13.11.2019.

The application for EC is approved based on the Serampore Municipality Building Petition No. 1067 of 2019-20 dated 22.10.2019.

5. Application for Environmental Clearance for the proposed expansion and modernization of Milan Mela complex by M/s. West Bengal Trade Promotion Organization at 3, JBS Haldane Avenue, Ward No. 58 of Kolkata Municipal Corporation, P.O. Dhapa, P.S. – Pragati Maidan, Kolkata – 700 046, West Bengal. (SIA/WB/NCP/75325/2018).

SEIAA considered the recommendation of SEAC and agreed with the same.

The application for EC is approved based on the KMC Building Permit No. 2019070110 dated 03.12.2019.

III. Stipulated conditions.

Proposed Residential Complex by M/s. Smart Vanijya Pvt. Ltd. at Plot Nos. – 1487(P), 1497(P), 1498, 1499(P), 1500(P), 1501, 1502, 1503, 1507, 1508, 1509, 1510, 1511, 1512, 1513, 1514, 1515, 1516(P), 1517(P) at Kadamtala, Khatian No. – 1839, 1840, 1841, 1842, 1843, 1920, 1921, 1922, 1923, 1924, Mouza – Baramohan Singhj, J.L. No. – 71, Atharakhai Gram Panchayat, P.S.- Matigara, Siliguri, Dist. – Darjeeling, West Bengal. (SIA/WB/MIS/131041/2019).

The SEIAA considered the recommendation of SEAC and agreed with the same.

SEIAA approved the proposal for stipulated conditions for Environmental Clearance.

IV. Miscellaneous

1. Transfer of Environment Clearance for Induction Furnace 05x20 T (0.3 MTPA) with matching LRF &CCM, Hot Rolling Mill-0.65 Million TPA and 45 MW Dolocharcoal mix based Captive Power Plant from EC of expansion and change in product mix & configuration of plant for Induction Furnace 15x20 T (0.9 MTPA) with matching LRF & CCM, Rolling Mill 0.84 MTPA (Hot Rolling Mill - 0.65 MTPA + Cold Rolling Mill – 0.19 MTPA) with 45 MW Coal Dolochar Mix based Captive Power Plant of M/s Orissa Metaliks Private Limited at Mouza – Mathurakismat (J.L. No. 114, Dag nos. 259, 260, 261, 262, 264, 278, 279, 288, 289, 290, 267/324) & Amba (J.L. No. 115, Plot nos. 91, 86, 83, 94, 82, 79, 77, 76, 75, 93, 90, 85), Village Gokulpur, Po. Shyamraipur, P.S. – Khragpur, Dist. Paschim Medinipur, West Bengal **Private** Limited. M/s Rashmi Metallurgical Industry to (SIA/WB/IND/22755/2017)

SEIAA considered the application made by the project proponent vide letter no. RMPL/Part_EC_Transfer/19-20/01 dated 09.12.2019. It was observed that they have applied for 'transferring the Partial EC' as mentioned in their affidavit dated 11.12.2019. As per EIA notification, there is no provision for transfer of partial EC.

Therefore, the application is rejected.

2. Transfer of Environmental Clearance letter No. 3001 / EN/ T-II-1/054/2007 dated 08/12/2015 granted for expansion of Cement Grinding Unit from 1.5 MTPA to 2.0 MTPA located at R. S. Plot Nos. 359 to 400, 402 to 424, 444 to 455, 457, 466, 490 to 498, 523 to 525, 527 to 536, 355/659, 371/660, 376/661, 391/713, 398/736, 399/670, 386/706, 404/663, 404/664, 407/665, 407/666, 420/671, 457/725, Village – Dhala, PO – Gankar, Block Raghnathganj, Dist. Murshidabad, West Bengal in favour of M/s Sonar Bangla Cement (A division of M/s Century Textile and Industries Limited) to M/s Ultratech Cement Limited. (SIA/WB/IND/127450/2019)

SEIAA considered the application made by the project proponent vide letter no. UTCL/ENV/MUM/2019/140 dated 08.11.2019 and observed that the project proponent has not applied in the requisite format along with other relevant documents.

The case is deferred for submission of additional documents.
