

**MINUTES OF THE 35TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 17TH JULY, 2018 AT PRANI SAMPAD
BHAVAN**

The thirty fifth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 17th July, 2018 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB - Block, Sector – III, Salt Lake, Kol-106. Following cases were discussed:

I. Cases for Final Environmental Clearance

1. Application for Environmental Clearance for the proposed residential complex at Plot No. 2149, Mouza – Hudrait, P.S. Rajarhat, New Town, Dist. North 24 Parganas, West Bengal by M/s. Kaushalya Township Pvt. Ltd & Others.

The Authority reviewed the recommendation of SEAC and it is found that the project proponent has submitted some copies of drawings from NKDA where a rubber stamped note stating 'No objection certificate for sanction of building plan for construction purpose with the Memo No. 2290(3)/NKDA/BPS-04(24)/2014 dated 16.05.2018' is there. Another stamped note 'sanctioned and approved dated 06.06.2018 by Executive Officer, Rajarhat Panchayet Samity' is found on the drawing which is not bearing any technical note in any form nor any sanction number. Thus it is observed that considering the scale of the project the appropriate sanctioning authority should approve the plan based on NOC issued by NKDA with proper building permit document and number.

2. Application for Environmental Clearance for the proposed construction of a new LPG bottling plant of 3X600 MT mounded storage vessels, and bottling capacity of 1,20,000 MTPA at Plot Nos. B1 & B2, Vidyasagar Industrial Park, Kharagpur, paschim Medinipur, West Bengal by M/s. Indian Oil Corporation Ltd.

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

3. Application for Environmental Clearance for the proposed project for installation of 3X15 T induction Furnaces, 01 no. 2 strand Continuous Caster, 1X15 MT Ladle Refining Furnace along with 1,80,000 Tonnes / Annum Rolling Mill in their existing premises at J.L. No. 58, Village, P.O. & Mouza – Bamunara, P.S. Kanksa, Dist. Paschim Bardhaman, West Bengal by M/s. Shree Waris Piya Steel Company Pvt. Ltd.

The Authority considered the recommendation of SEAC and decided to request the project proponent to submit a site plan in scale showing detailed distribution of all uses especially 33% plantation area as declared, paved area etc. with different colours along with a legend.

II. Stipulated Conditions

- 1. Application for Environmental Clearance for the proposed expansion of the residential complex 'SWARNAMANI' at Premises No. 163 B, Manicktala Main Road, Kolkata – 700 054, West Bengal by M/s. Mani Square Ltd.**

The SEIAA approved the stipulated conditions for Environmental Clearance recommended by the SEAC with the additional condition that mutation certificate to be obtained from KMC.

- 2. Application for Environmental Clearance for the proposed expansion and modernization of Milan Mela complex at 3, JBS Haldane Avenue, Ward No. 58 of Kolkata Municipal Corporation, P.O. Dhapa, P.S. – Pragati Maidan, Kolkata – 700 046, West Bengal by M/s. West Bengal Trade Promotion Organization.**

The SEIAA approved the stipulated conditions for Environmental Clearance recommended by the SEAC with the additional condition that the project proponent should explore the possibilities of using alternative paving materials in order to reduce the percentage of paved area.

- 3. Application for Environmental Clearance for the proposed residential complex at L.R. Dag Nos. 898, 900, L.R. Khatian Nos. 4382-4421, 4424-4428, 4506 and 4542, Mouza – Mankundu, Holding No. 183/1, Khan Road, P.O. & P.S. – Bhadreswar, Municipality - Bhadreswar, J.L. No. 9, Ward No. 20, Dist. Hooghly, West Bengal by M/s. PGE Infosolutions Pvt. Ltd. & Others.**

The SEIAA approved the stipulated conditions for Environmental Clearance recommended by the SEAC.

III. Miscellaneous

- 1. Withdrawal of application for Environmental Clearance for the proposed sand and stone mine project of area 97 acres at Vill – Tari Guria & Baniakhari, PS – Matigara, Siliguri, Dist – Darjeeling, West Bengal.**

The online application was submitted vide Proposal No. SIA/WB/MIN/17677/2016 on 03.11.2016 by CHAKRABORTY MINERAL. The application for withdrawal vide letter dated 15.05.2018 has been recommended by SEAC vide Memo No. 285-2N-06/2017(E) dated 25.05.2018 and is hereby approved.

2. **Fresh online application made for Environmental Clearance for the proposed sand and stone mine project of area 97 acres at Vill – Tari Guria & Baniakhari, PS – Matigara, Siliguri, Dist – Darjeeling, West Bengal by Shri Shyamal Kumar Sanyal.**


The online application was submitted vide Proposal No. SIA/WB/MIN/22357/2018 on 18.06.2018 by M/s. SHYMAL KUMAR SANYAL. Subsequently it is found that the project project proponent Sri Shyamal Kumar Sanyal expired on 26.12.2017 vide KMC Death Certificate No. HOSPL/2018/000588 (OLD REGN. No. 597) dated 11.01.2018. Hence it is implied that the application stands cancelled.

3. **Request for change of the name of the project mentioned in Environmental Clearance for proposed residential project at Diamond Harbour Road, Joka, Mouza - Daulatpur & Sarmestarchak, P.S. Bishnupur under Kulerdari Gram Panchayat, Dist – South 24 Parganas, West Bengal by M/s PS Vinayak Complex LLP.**


SEIAA considered the submission of the project proponent vide No. THE 102/ 00101 dated 01.06.2018 and approved the prayer for change of name of project from 'THE 101' to 'THE 102' in the Environmental Clearance issued vide No. 431/EN/T-II-1/013/2017 dated 22.02.2018 without any change in the EC conditions.

4. **Request for Change of name of project proponent for Environmental Clearance for the proposed residential complex Limited at 88A, B. L. Saha Road, JL No.10, Khatian Nos. 36, 38, 81 & 90, Borough No. XIII, P.O. & P.S. Behala, K.M.C. Ward No. 116, Kolkata – 700053, West Bengal by M/s. South City Projects (Kol).**

SEIAA considered the submission of the project proponent and in view of the request for change of the name of the project proponent to multiple names, it was decided to inform the project proponent to submit a Power of Attorney in favour of one company / entity / agency who will be responsible for implementation of the conditions of Environmental Clearance issued vide No. 1379/EN/T-II-1/038/2012 dated 06.06.2018.
