

**MINUTES OF THE 28TH MEETING OF STATE LEVEL ENVIRONMENT IMPACT
ASSESSMENT AUTHORITY (SEIAA) HELD ON 19TH MARCH, 2018 AT PARIBESH
BHAVAN**

The twenty-eighth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 19th March, 2018 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Bidhannagar, Kol-106. Following cases were discussed:-

I. Stipulated Conditions

- 1. Application for Environmental Clearance for the proposed residential cum commercial complex at Plot No. 257/A, Deshpran Sashmal Road, Ward No. 94, under KMC, Kolkata – 700 033, West Bengal by M/s. Nirvana Devcon LLP**

The SEIAA approved the stipulated conditions for Environmental Clearance proposed by the SEAC.

- 2. Application for Environmental Clearance for the proposed residential complex at Premises No. 11, Deshpran Sasmal Road, K.M.C. Ward No. 89, Borough – X, P.O. Tollygunge, P.S. Charu Market, Kolkata – 700 033, West Bengal by M/s. Muskan Highrise Pvt. Ltd.**

The SEIAA approved the stipulated conditions for Environmental Clearance proposed by the SEAC.

- 3. Application for Environmental Clearance for the proposed residential complex at Premises No. 48, Manmohan Banerjee Road, Ward No.118, Borough No. XIII under KMC, P.S. Behala, Kolkata – 700 038, West Bengal by M/s. Allworth Tradecom Pvt. Ltd. & Others.**

The SEIAA approved the stipulated conditions for Environmental Clearance proposed by the SEAC.

II. Miscellaneous

- 1. Extension of validity – Application for Environmental Clearance for the proposed Greenfield Aerotropolis Township (PHASE I) at Andal, Vill. – Tamla, Dhokinkhanda, Mahira, Khandra, Amloka, Banguli, Durgapur Taluk, Dist. – Paschim Bardhaman, West Bengal by M/s. Bengal Aerotropolis Projects Ltd.**

SEIAA considered the submission of the project proponent vide letter No. BAPL/DGP/INFRA(PI)/L/SEIAA/17-18/0109 dated 31.0.2018 and in view of MoEF & CC Notification No. 2944(E) dated 14.09.2016 approved the prayer for extension of validity of Environmental Clearance issued vide Memo No. 2041/T-II-1/025/2009 dated 11.08.2011 up to 10.08.2021.

2. **Amendment - Application for Environment Clearance for the proposed "Calcutta Riverside Township" at Batanagar, Maheshtala Municipality, Dist. 24 Pgs.(S) by M/s Riverbank Developers Pvt. Ltd. & IT SEZ by M/s Riverbank Holdings Pvt. Ltd.**

SEIAA considered the recommendation of the SEAC vide memo no.66-2N-11/2008(E) dated 31.01.2018 and decided for amendment of Environmental Clearance conditions regarding solid waste management and water supply.

3. **Extension of validity - Application for Environment Clearance for the proposed "Calcutta Riverside Township" at Batanagar, Maheshtala Municipality, Dist. 24 Pgs.(S) by M/s Riverbank Developers Pvt. Ltd. & IT SEZ by M/s Riverbank Holdings Pvt. Ltd.**

SEIAA considered the recommendation of the SEAC vide memo no.66-2N-11/2008(E) dated 31.01.2018 and in view of MoEF & CC Notification No. 2944(E) dated 14.09.2016 decided that no further extension of Environmental Clearance issued vide Memo no. EN/1283/T-II-1/066/2008 dated 19.06.2008 beyond 19.06.2018 can be granted.

4. **Amendment - Application for Environmental Clearance for the proposed expansion of Day care and oncology building and alterations of service block and new meditation Centre at 58, Canal Circular Road, Kolkata - 700 054 by M/s. Apollo Gleneagles Hospital Ltd.**

The Authority examined the submission of the project proponent and decided to refer the case to SEAC for necessary appraisal.

5. **Amendment - Application for Environmental Clearance for the proposed Cement Grinding Unit at JL No. 82, Vill. & Mouza - Ketlapur, P.O. Rukni, Block & P.S. Para, Dist.-Purulia, Pin - 723 145 by M/s. Mirdha Cement Private Limited.**

The Authority examined the submission of the project proponent and decided to refer the case to SEAC for necessary appraisal.

6. **Amendment - Application for Environmental Clearance for the proposed expansion of existing Stand alone Cement Grinding Unit from 0.6 MTPA to 1.8 MTPA at Vill-Madukunda, Tehsil-Raghunathpur, P.O-Sunuri, Dist - Purulia, Pin-723121 West Bengal by M/s. ACC Cement Ltd.**

The Authority examined the submission of the project proponent and decided to refer the case to SEAC for necessary appraisal.

7. **Change of Name - Application for Environmental Clearance for the proposed Cement Grinding Unit of capacity 5 MTPA and CPP of capacity 20 MW at Vill - Parbatpur & Digha, Tehsil - Raghunathpur, Dist - Purulia, West Bengal by M/s. Shree Cement Ltd.**

SEIAA considered the submission of the project proponent and approved the prayer for change of name of project proponent for Environmental Clearance vide No.1197/EN/T-II-1/001/2016 dated 12.06.2017 from 'Shree Cement Ltd.' to 'West Bengal Grinding Unit (A unit of Shree Cement Ltd.).'


8. Prayer to withdraw - Application for Environmental Clearance for the proposed manufacturing unit for production of Linear Alkyl Benzene Sulphonic Acid (LABSA) & Dil. H₂SO₄ at Ganesh Complex, Mouza - Raghudevpur, JL No. - 99, Panchla, P.S. Uluberia, Dist. Howrah, West Bengal by M/s. Samrat Management Pvt. Ltd.


SEIAA considered the prayer of the project proponent dated 15.01.2018 and allowed withdrawal of application for Environmental Clearance.


9. Letter from SEAC with respect to application for Environmental Clearance for proposed residential building "Tower Quest" at premises no. 33A, Canal Circular Road, Kolkata - 700 054 by M/s. Bloombuilt Construction Pvt. Ltd. & Others.

SEIAA considered the recommendation of SEAC and in view of letter No. KMC/DG(B)/063/17-18 dated 03.08.2017 it was decided that the project proponent may be advised to apply afresh for the total project against Premises No. 163B, Manicktala Main Road as an 'expansion proposal'.

It was further decided that before applying for the entire project, the project proponent needs to withdraw any other application for Environmental Clearance whose area falls within premises no. 163B, Manicktala Main Road.
