

**MINUTES OF THE 56<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT  
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 27<sup>TH</sup> JUNE, 2019  
AT PRANI SAMPAD BHAVAN**

The fifty-sixth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 27<sup>th</sup> June, 2019 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5<sup>th</sup> Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

**I. Environmental Clearance**

1. Application for environmental clearance for proposed expansion of capacity of standalone Cement Grinding Unit from 1.6 MTPA to 2.0 MTPA at Mohitnagar Railway Crossing, JL No. 5 & 7, Mouza – Kharia & Patkata, Dist – Jalpaiguri, West Bengal by M/s. Star Cement Limited. (SIA/WB / IND / 105345 / 2019)

**The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance in supersession of the earlier Environmental Clearance issued vide No. 2077/EN/T-II-1/047/2012 dated 14/08/2015. In view of the O.M. No.22-76/2014-IA-III dated 07.10.2014 it is to be noted that EC granted for the project on the basis of agreement made for the additional land shall become invalid in case the additional land for the project site turns out to be different from the land considered at the time of appraisal of the project and as mentioned in the EC.**

2. Application for environmental clearance for proposed construction of 2 new Common Effluent Treatment Plant (CETP) Modules each of 5 MLD treatment capacity for Calcutta Leather Complex at Bantala, West Bengal by Micro, Small & Medium Enterprises and Textiles Department, GoWB. (SIA / WB/ MIS / 36396 / 2018).

**The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.**

3. Application for environmental clearance for proposed expansion of Residential Building at 992, E.M. bypass, Ward No. 58 of KMC, PS – Pragati Maidan, Borough – VII, Kolkata – 700 105, West Bengal by M/s AHW Unimark Consortium LLP.

**The Authority considered the recommendation of SEAC and the letter from Special Municipal Commissioner (Revenue), Kolkata Municipal Corporation vide No. KMC/DG(B)/10/19-20 dated 11.06.2019 and approved the proposal for Environmental Clearance.**



## II. Stipulated conditions.

1. Application for stipulating conditions for environmental clearance of proposed expansion of Medica Superspecialty Hospital at Premises No. 324, Barakhola, 127, Mukundapur, PS – Purba Jadavpur under KMC Ward No. 109, Kolkata – 700 099, Dist. South 24 Parganas, West Bengal by M/s. Eastern India Healthcare Foundation. (SIA / WB / NCP / 93649 / 2019)

**The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC with the additional condition that the project proponent shall submit the details of storage, usage and disposal (both solid and liquid quantity involved) of different radioactive material and radioactive waste along with the sanctioned building plan.**


## III. Miscellaneous
