MINUTES OF THE 61ST MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 27th AUGUST, 2019 AT PRANI SAMPAD BHAVAN

The sixty first meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 27th August, 2019 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Stipulated conditions.

Proposed Residential Complex by M/s. Smart Vanijya Pvt. Ltd at Plot Nos. – 1487(P), 1497(P), 1498, 1499(P), 1500(P), 1501, 1502, 1503, 1507, 1508, 1509, 1510, 1511, 1512, 1513, 1514, 1515, 1516(P), 1517(P), at Kadamtala, Khatian No. – 1839, 1840, 1841, 1842, 1843, 1920, 1921, 1922, 1923, 1924, Mouza – Baramohan Singhj, J.L. No. – 71, Atharakhai Gram Panchyat, P.S.-Matigara, Siliguri, Dist. – Darjeeling, West Bengal. (SIA/WB/NCP/75755/2018).

The SEIAA considered the submission made by the project proponent vide letter no. Nil dated 07.08.2019 and observed the following:

- 1. The exclusive tree plantation area shown in the drawing is unfit for growing tree species considering the orientation of the plot (based on the sun-path diagram submitted) and the suggested layout of the buildings. Further, some narrow strips included in the tree plantation area are not at all suitable for growing trees. Such narrow strips should be excluded from the calculation of exclusive tree plantation area and may be included as other green areas.
- 2. The details showing MLCP in the drawing submitted do not mention the number of total car parking and the area available for MLCP.
- 2. Proposed expansion of township "URBANA" by M/s. Bengal NRI Complex Ltd. at 782 & 783 Anandapur, P.O. EKTP, P.S. Tiljala, Kolkata 700107, West Bengal.(SIA/WB/NCP/30119/2018)

The SEIAA considered the submission made by the project proponent vide letter no. BNRI/ENGG/GD/PCB/4746/2019-20 dated 09.08.2019 and it was decided that in view of the close proximity of the project site with the East Kolkata Wetlands, a field verification is required. Member Secretary, SEIAA is requested to take suitable action.

II. Miscellaneous

 Application for Environment Clearance for Storage Building "Flipkart Big Box" by M/s Insta Kart Services Pvt. Ltd.(Flipkart Group Company) at Town/ Village - Haringhata, Dist - Nadia, Tehshil - Haringhata. Pin-741249, West Bengal (SIA/WB/MIC/104002/2019).

The SEIAA considered the recommendation of SEAC and decided that the proposed project of M/s. Insta Kart Services Pvt. Ltd. is exempted from obtaining EC with the following conditions:

- 1. No industry/activity mentioned in the schedule of EIA Notification, 2006 and its amendment, attracting the provisions of EC shall be allowed.
- 2. Necessary permission from other Govt. Authorities, as applicable needs to be obtained.

2. Exemption of EC for -

- a) Proposed establishment of one LPG yard (Storage facility) consisting of 2 nos 10 MT bullet by **M/s Exide Industries Ltd.** at J.L. No. 135, 136, Khatian No. 1, Dag No. 1, Durgachak, Haldia 721602, West Bengal.(SIA/WB/IND2/29737/2018).
- b) Proposed expansion of Bulk Storage LPG/Propane/Butane Bottling and Storage Plant from 50MT to 300MT by **M/s Hindustan Aegis LPG Limited** at Haldia Dock Complex, Mouza-Bijoyramchak, JL No. 137, PO & PS-Durgachak, Haldia, East Medinipur, Pin-721602, West Bengal. (SIA/WB/IND2/27672/2018)
- c) Proposed construction of Additional tankage and necessary revamping work at Mourigram Terminal with the existing plant at IOCL, Mourigram, by M/s. Indian Oil Corporation Ltd.(SIA/WB/IND2/21542/2018).

SEIAA considered the application made by the project proponent vide letter no. JSWCL/Salboni/SEIAA/2019-20 dated 28.06.2019 and observed that there is no provision for <u>Multi-furcation</u> of an existing EC as per the provision of EIA notification 2006 and its amendments.
