

**MINUTES OF THE 22<sup>ND</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT  
ASSESSMENT AUTHORITY (SEIAA) HELD ON 27<sup>TH</sup> NOVEMBER, 2017 AT PARIBESH  
BHAVAN**

The twenty-second meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 27<sup>th</sup> November, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Salt Lake, Kol-106. Following cases were discussed:

**I. Cases for Final Environmental Clearance**

**1. Application for Environmental Clearance for the proposed expansion of hotel and service apartment complex at premises no. 30-111, plot no. BG-9, AA-1, New Town, P.S. Rajarhat, Dist. North 24 Parganas, West Bengal by M/s. Anik Industries Ltd.**

SEIAA examined the documents submitted by the project proponent. It is found that the detailed plan and sectional drawings of the STP, compost plant and rainwater harvesting reservoir are not in order and need to be submitted after incorporating the necessary details:

- i) Scaled drawings (both plan and section) of STP, compost plant and rainwater harvesting tank showing portion of adjacent areas mentioning the levels and entry/exit to the facilities.
- ii) Location of the said facilities in the ground floor plan mentioning the levels.
- iii) All drawings should be signed by authorized technical person.
- iv) Appropriate drawing scale should be used so that the drawings are legible and can be deciphered.

**2. Application for Environmental Clearance for the proposed expansion of Housing Complex at Mouza – Domjur, Mouza – Makardah and Mouza – Pubannapara, P.S. Domjur, Dist. Howrah, West Bengal by M/s. Riya Manbhari Projects LLP.**

SEIAA examined the documents submitted by the project proponent. It is found that the detailed plan and sectional drawings of the STP, compost plant and rainwater harvesting reservoir are not in order and need to be submitted after incorporating the necessary details:

- i) Scaled drawings (both plan and section) of STP, compost plant and rainwater harvesting tank showing portion of adjacent areas mentioning the levels and entry/exit to the facilities.
- ii) Location of the said facilities in the ground floor plan mentioning the levels.
- iii) All drawings should be signed by authorized technical person.
- iv) Appropriate drawing scale should be used so that the drawings are legible and can be deciphered.
- v) Compliance report of environmental clearance conditions for the existing/ongoing project to be submitted.

3. **Application for Environmental Clearance for the proposed expansion (Phase-2) of Residential Complex "Mani Casadona" at Plot No. IIF/04, Action Area -II, New Town, PS - Rajarhat, New Town, PS - Rajarhat, New Town, Kolkata Development Authority, Dist. - 24 Parganas (North), West Bengal by M/s. Magus Bengal Estates LLP.**

SEIAA examined the documents submitted by the project proponent. It is found that the detailed plan and sectional drawings of the STP, compost plant and rainwater harvesting reservoir are not in order and need to be submitted after incorporating the necessary details:

- i) The SEAC is requested to appraise the project after obtaining the necessary Compliance Report of the ongoing project from the project proponent.
- ii) Scaled drawings (both plan and section) of STP, compost plant and rainwater harvesting tank showing portion of adjacent areas mentioning the levels and entry/exit to the facilities.


## **II. Miscellaneous**

1. **Violation & Prayer to withdraw - Application for Environmental Clearance for proposed parking plaza cum hotel cum commercial complex at CS Plot No. 3629(P), 3630(P), 3601(P) and layout Plot No. 1665 of Mouza - Faridpur, Commercial Zone City Centre, Holding No. N/39, Holding ID No. 64457, Ward No. C/22, Sahind Khudiram Sarani, City Centre, Durgapur - 713 216, Dist. - Burdwan, West Bengal by M/s. Ganapati India International Pvt. Ltd.**


In view of the Memo No. 239-7/WPBD/Cont.(7260)/17 dated 11.09.2017, it is observed that the project proponent have almost completed the project work without obtaining EC and NOC. The project proponent had earlier applied for EC on 25.01.2016. SEAC is requested to examine the prayer of the project proponent for withdrawal of application for EC and send their recommendation.

2. **Amendment of environmental clearance to commercial complex (acropolis) and stadium (Gitanjali) at 1858, Rajdanga Main Road, Kolkata - 107 by M/s. Merlin Projects Ltd.**

In view of the application made by the project proponent vide Ref. No. Nil dated 06.11.2017 and also in reference to the NOC of the project issued by the KMDA vide Ref. No. 1614(B)/KMDA/Spl. Secy. dated 17.10.2006, Ref. No. 521/AD/KMDA/W-18 dated 24.01.2017 and Completion Certificate issued by KMC vide Ref. No. 119/XII/2015-16 dated 31.12.2015, SEAC is requested to examine the amendment application and send their recommendation.
