

**MINUTES OF THE 50TH MEETING OF STATE LEVEL ENVIRONMENT
IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 30TH MARCH, 2019
AT PARIBESH BHAVAN**

The fiftieth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 30th March, 2019 in the Conference Room of Paribesh Bhavan, 10A, Block LA, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Cases for Final Environmental Clearance

1. Application for Environmental Clearance for the proposed residential complex L.R. Dag No. 898, 900, LR Khatian Nos. 4382-4421, 4424-4428, 4506 and 4542, Mouza – Mankundu, Holding No. 183/1, Khan Road, PO & PS – Bhadreswar, Municipality – Bhadreswar, JL No. 09, Ward No. 20, Dist – Hooghly, PIN – 712136, West Bengal by M/s. PGE Infosolution Pvt. Ltd. & Others. (SIA/WB/NCP/71131/2017).

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

2. Application for Environmental Clearance for the proposed china Clay and Fire Clay Mines at Vill – Mokdamnagar & Tentulberia, PS – Mohammad Bazar, Dist – Birbhum, West Bengal by M/s. West Bengal Mineral Development & Trading Corporation Ltd. (SIA/WB/MIN/30499/2017).

The Authority considered the recommendation of SEAC and it was observed that as per clause 3.9.2 of EIA Report submitted by the project proponent, the lease area has a number of eucalyptus plantations. Therefore, it was decided to refer the matter to PCCF (HoFF), West Bengal for obtaining a NOC/clearance in this regard.

3. Application for Environmental Clearance for the proposed expansion of residential complex at 991, E.M. Bypass, PS – Pragati Maidan, KMC Ward No. 58, Borough- VII, Kolkata – 700 046 by M/s. Concast Infrastructure Pvt. Ltd.

The Authority considered the recommendation of SEAC and observed that the letter received from KMC vide Memo No. Ch.E&S/503/2018-19 dated 13.02.2019 does not address the query placed by SEIAA vide their Memo No. 3286/EN/T-II-1/057/2015 dated 28.09.2018 regarding the change of land use from 'IT' to 'Residential'. The project proponent has further informed vide Memo No. Nil dated 31.10.2018 that KMC has mutated the said land in favour of M/s. Concast Infrastructure Pvt. Ltd. Therefore, the relevant Mutation Certificate may be submitted by the project proponent.

4. Application for Environmental Clearance for the proposed Commercial Building at Holding No. 449/A, G.T. Road, Lot – 1, Serampore, JL No. 15, Mouza – Mahesh, PS – Serampore, Dist – Hooghly, under Serampore Municipality, West Bengal by M/s. Happy Niketan Pvt. Ltd. (SIA/WB/NCP/88563/2018)

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

5. Application for Environmental Clearance for the proposed expansion project by installation of 2x7 MT Induction Furnaces for production of 4200MT/month with Ladle Refining Furnace and 8000 MT/month Rolling Mill at JL No. 58, 65, Bamunara Industrial Area, Vill & PO – Bamunara, Mouza – Bamunara, PS – Kanksha, Dist – Paschim Bardhaman, West Bengal by M/s. Durgapur Iron & Steel Co. Pvt. Ltd. (SIA/WB/IND/28743/2017)

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

6. Application for Environmental Clearance for the proposed expansion of the housing complex at Plot No. 34B, B.T. Road, Ward No.1 of Kolkata Municipal Corporation, Kolkata – 700 002, West Bengal by M/s. Muktamani Vanijya Pvt. Ltd.

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

II. Stipulated Conditions

1. Proposed expansion of Residential Complex “THE 42” by M/s. Chowringhee Residency Pvt. Ltd. at 42B, Chowringhee Road, under KMC Ward No. 63, PS – Shakespeare Sarani, Kolkata – 700 071, West Bengal.
(SIA/WB/NCP/76550/2018)

The SEIAA considered the recommendation of SEAC and it was decided that the project proponent would be required to submit the following :


- i. **A legible set of KMC sanctioned plans vide Building Permit No. 2012070281 dated 14.12.2012 along with the matching floor wise area statement for the total built up area of 63,614.62 sqm. as per earlier EC No. EN/2087/T-II-1/063/2013 dated 19.08.2014.**
- ii. **A legible set of KMC sanctioned plans vide Building Permit No. 2018070238 dated 18.01.2019 along with the matching floor wise area statement for the total built up area of 61,548.90 sqm.**


2. Proposed Residential Building by M/s. Aswagandha Merchants Pvt. Ltd. & Ors. at 47, Matheswartala Road, PS – Tangra, Kolkata – 700 046, West Bengal (SIA/WB/MIS/82250/2018).


The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC.

3. Proposed ICVT project and commercial development at Premises No. 04-0030, Plot No. AF-II, Action Area – I, New Town, Rajarhat, North 24 Parganas, West Bengal by M/s. Indian Craft Village Trust.

The SEIAA considered the recommendation of SEAC and approved the stipulated conditions for Environmental Clearance proposed by the SEAC.
