MINUTES OF THE 1ST MEETING OF STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (SEIAA) HELD ON 10TH JUNE, 2020 AT PRANI SAMPAD BHAVAN

The first meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 10th June, 2020 in the Conference Room of Environment Department, Prani Sampad Bhavan, 5th Floor, LB – Block, Sector – III, Salt Lake, Kolkata – 700106. Following cases were discussed:

I. Environmental Clearance

 Application for Environmental Clearance for the Proposed Palsara Black Stone Mine by M/s West Bengal Mineral Development & Trading Corporation Ltd. at Plot No. 3547, J.L. No. 121, Mouza & Vill- Palsara, PS - Kashipur, under Kashipur Block of Dist.-Purulia, West Bengal. (SIA/WB/MIN/141542/2020)

SEIAA considered the recommendation made by SEAC and observed the following:

- A plantation plan specifying the number and type of species, spacing for the total area of 5.03 Ha. as specified by the project proponent is required to be submitted.
- 2. Total financial outlay for the plantation creation and maintenance is to be submitted.

Thus the project proponent is required to submit the above mentioned documents.

Therefore, the application for EC is deferred (Additional Information).

 Application for Environmental Clearance for the proposed expansion of Residential Complex by M/s Unimark Mirania Projects LLP. at Holding No. Garagachha, Rajpur-Sonarpur Municipality Ward No. 1, Mouza – Garagachha, PS – Sonarpur, Dist.-24 Parganas (South), West Bengal. (SIA/WB/NCP/93719/2019)

SEIAA considered the recommendation of SEAC.

The application for EC is approved based on the Building Permit No. 209/Rev/CB/01/90 dated 18.11.2019 issued by Rajpur-Sonarpur Municipality.

3. Application for Environmental Clearance for the proposed expansion project from 90,000 TPA billet (2x12T Induction Furnace) and 1,62,000 TPA wire rods to 1,92,000 TPA wire rods and 60,000 TPA HB wires by adding 1x15T induction furnace by M/s. Supershakti Metaliks Limited at Kanjilal Avenue, Tehsil – Durgapur, Dist. – Paschim Bardhaman, West Bengal. (SIA/WB/IND/30361/2018)

SEIAA considered the submission made by the project proponent vide their letter no. Nil dated 13.02.2020 and observed that they are required to submit the plantation details in the proposed area earmarked for raising the plantation to be allotted on lease hold basis by Asansol Durgapur Development Authority. They are further required to submit the lease document regarding the transfer of land by ADDA to the project proponent.

Therefore, the application for EC is deferred (Additional Information).

II. Violation.

 Application for Environmental Clearance for the proposed expansion of Residential cum Commercial Complex "Saltee Spacio" by M/s Shree Bishnu Nirman Pvt. Ltd. at 1, Khudiram Bose Sarani, South Dum Dum Municipality Ward No. 21, P.S. Dum Dum, Kolkata - 700 028, West Bengal.

SEIAA considered the submission made by the project proponent vide their letter no. Nil dated 25.02.2020. In compliance of the order dated 11.02.2020 by Hon'ble Calcutta High Court in the W.P. No. 1370(W) of 2020, SEIAA decided that the SEAC is required to process and appraise the case under violation category.
